

TERMS OF USE

Welcome to the Crop Insurance in America website owned and maintained by National Crop Insurance Services ("NCIS"). Your use of our website at www.cropinsuranceinamerica.org, which includes NCIS's mobile sites or downloadable mobile applications and NCIS's social media pages (collectively, the "Site") or any of the services offered on or through the Site (the "Services") is subject to these Terms of Use (the "Terms"). Your use of the Site constitutes your binding acceptance of these Terms, including any modifications made to the Terms. 4. **User Obligations.** In consideration of your use of the Site and/or the Services, you agree to be subject to certain obligations. You and NCIS irrevocably waive, to the fullest extent permitted by law, any objection that you/it may now or hereafter have to the laying of the venue of any proceeding brought in any such court or any claim that a legal proceeding commenced in such court has been brought in an inconvenient forum.
- 18. Waiver.** NCIS's failure to exercise or enforce any right or provision of the Terms shall not constitute a waiver of such right or provision unless acknowledged and agreed to by NCIS in writing.

19. **Severability.** If any provision of these Terms is held to be illegal, invalid or unenforceable under any present or future laws, such provision shall be fully severable, and the remaining provisions shall constitute the parties' agreement.
20. **Time Limitation.** You agree that regardless of any statute or law to the contrary, any claim or cause of action arising out of or related to the Terms or use of the Site must be filed within two (2) years after such claim or cause of action arose or be forever barred.
21. **Headings.** The section headings and sub-headings contained in the Terms are for convenience only and have no legal or contractual effect.
